THE MEXICO FUND, INC. DECLARES DIVIDEND DISTRIBUTION

Washington, D.C., September 30, 2009 -- The Mexico Fund, Inc. (NYSE: MXF) announced today that the Board of Directors declared a cash dividend distribution of \$0.42 per share to stockholders of record on October 19, 2009, which is payable on October 29, 2009. According to the terms of the Fund's Managed Distribution Plan (MDP), this dividend distribution is the equivalent of 2.5% of the Fund's net asset value per share (NAV) as of December 31, 2008.

The amount of distributable income for each fiscal period depends on the aggregate gains and losses realized by the Fund during the entire year. Distributions may consist of net investment income, capital gains and return of capital, but the character of these distributions cannot be determined until after the end of the Fund's fiscal year.

However, under the Investment Company Act of 1940, the Fund is required to indicate the source of each distribution to stockholders. The following table sets forth an estimate of the source of the October 2009 distribution and for the current fiscal year:

³ The Current Annualized Distribution Rate is the Cumulative Distribution Rate as of August 31, 2009 annualized as a percentage of the Fund's NAV at the same date.

⁴ Fiscal Year Cumulative Total Return is the percentage change in the Fund's NAV from November 1, 2008 through August 31, 2009, including distributions paid and assuming reinvestment of those distributions.

⁵ Cumulative Distribution Rate for the Fund's current fiscal period (November 1, 2008 through August 31, 2009) measured on the dollar value of distributions in the period as a percentage of the Fund's NAV as of August 31, 2009.
