THE MEXICO FUND, INC. DECLARES DISTRIBUTION

Washington, D.C., June 9, 2010 -- **The Mexico Fund, Inc. (NYSE: MXF)** announced today that the Board of Directors declared a distribution of \$0.63 per share to stockholders of record on July 7, 2010, which is payable in cash on July 22, 2010. Under the Fund's Managed Distribution Plan (MDP), the Fund pays quarterly distributions at an annual rate of 10% of the Fund's net asset value (NAV) per share as of December 31, 2009.

The amount of distributable income for each fiscal period depends on the aggregate gains and losses realized by the Fund during the entire year. Distributions may consist of net investment income, capital gains and return of capital, but the character of these distributions cannot be determined until after the end of the Fund's fiscal year.

However, under the Investment Company Act of 1940, the Fund is required to indicate the source of each distribution to stockholders. The following table sets forth an estimate of the source of the July 2010 distribution and for the current fiscal year:

³ The Current Annualized Distribution Rate is the Cumulative Distribution Rate as of May 31, 2010 annualized as a percentage of the Fund's NAV at the same date.

⁴ Fiscal Year Cumulative Total Return is the percentage change in the Fund's NAV from November 1, 2009 through May 31, 2010, including distributions paid and assuming reinvestment of those distributions.

⁵ Cumulative Distribution Rate for the Fund's current fiscal period (November 1, 2009 through May 31, 2010) measured on the dollar value of distributions in the period as a percentage of the Fund's NAV as of May 31, 2010.

A return of capital distribution does not necessarily reflect the Fund's investment performance and should not be confused with "yield" or "income."

The amounts and sources of distributions reported above are only estimates and are not being provided for tax reporting purposes. The actual amounts and sources of the amounts for accounting and tax reporting purposes will depend upon the Fund's investment experience during the remainder of the calendar year and may be subject to changes based on tax regulations. The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report the distribution for federal income tax purposes.
